**JANUARY 22, 2024**

Mayor Chegwidden called the Meeting to Order.

Mayor Chegwidden read the Open Public Meeting Statement.

**Gary Cole, 6 Robert St.:** Mr. Cole stated his concern regarding speeding on Robert Street, especially during workday commuting hours. He requested a traffic study be done between 6-8am and 3-6pm. Chief Young indicated they could do a traffic survey and explained the survey will be conducted 24/7 for a minimum of 4 days. The Police Department will report back to the Council after the survey is finished.

Mr. Cole expressed his concern about people moving into neighboring homes in the middle of the night. He was advised to report any incidents to the Zoning Officer.

**Alexander McCusker, 34 Ford Ave.:** Alexander asked about the status of the water park the town was going to build at the park. Mayor Chegwidden advised improvements to Columbia Street Park are planned, however, there will not be a water feature due to liability concerns.
