#### REGULAR MEETING MAYOR AND COUNCIL JUNE 13, 2016

## **Opening Items**

Mayor Chegwidden called the Meeting to Order.

Mayor Chegwidden read the Open Public Meeting Statement.

# <u>Roll Call</u>

Mayor Chegwidden requested Roll Call:

Council President Norton – Present Councilman Binkoski – Absent, Excused Councilman Corbett – Present Councilwoman Hayes- Present Councilwoman Wickenheisser- Present Councilman Yeager- Present

Also in attendance were Administrator/CFO Jon Rheinhardt, Borough Clerk Gabrielle Evangelista, and Attorney George Johnson.

Mayor Chegwidden asked for a moment of silence for the victims of the Orlando attack and for Bill Webber.

## <u>Flag Salute</u>

Mayor Chegwidden led those in attendance with the salute to the American Flag.

## **Presentation**

William McKelvey made a presentation about a proposal for a vintage trolley shuttle on the former RR right of way above the canal in Hugh Force Park to complement a future canal boat ride and increase tourism potential. The project would be funded by the Liberty Historic Railway as well as other organizations. Mayor Chegwidden advised that the Morris County Park Commission is also on board. Right now we are waiting on the survey from the Park Commission to be completed. Councilman Corbett and Councilwoman Hayes had questions about what the cost will be relating to insurance. Mr. Rheinhardt advised that the exact tract of land being discussed is actually owned by the County so it will be looked into. More discussion about this followed.

## **Open to the Public**

In accordance with Local Ordinance O-18-03, "Persons making public comment at the first public portion shall be limited to five (5) minutes. During the second public portion, the Mayor or Council President shall have the discretion to terminate any repetitive, irrelevant or excessive public comment in the interest of permitting all members of the public time to speak on any governmental issue and completing the public business within a reasonable period of time".

Mayor Chegwidden opened the meeting to the public.

<u>Joe Macasek, President of NJ Canal Society:</u> Mr. Macasek advised that the Canal Society is in agreement with and excited about the project mentioned in the presentation.

No one else wishing to be heard, Mayor Chegwidden closed the meeting to the public.

## <u>Ordinance</u>

Councilman Corbett presented O-14-16, "Bond Ordinance Providing for the Construction of a Water Tank in and by the Borough of Wharton, In the County of Morris, New Jersey, Appropriating \$1,500,000 therefor and Authorizing the Issuance of ," on second reading by title only.

Mayor Chegwidden opened the meeting to the public for questions or comments on this Ordinance only.

No one wishing to be heard, Mayor Chegwidden closed the meeting to the public.

A motion was made by Councilman Corbett and was seconded by Councilman Yeager to adopt O-14-16 on second and final reading.

## <u>Discussion</u>

- 1. Parking on Washington Street: Ms. Evangelista advised the Council that we are considering making residential parking permits for Washington Street for when the new apartments are constructed in order to make sure that the people who live on Washington Street can continue to park on their street. A lot of cities have this practice, they create "zones" and the permits are only good for certain "zones." Mayor Chegwidden advised that he was approached by people who live on the street asking for something like this.
- 2. Recreation with Nearby Towns: Council President Norton advised that he has been working with Rec. Directors and Council People from the towns who send students to Morris Hills Regional District about creating a joint recreation program for some youth sports. He wants to get feedback from the rest of the Council about the idea. They've discussed using soccer as a pilot project to see if it would work. After more discussion including Ms. Ghebreal, everyone agreed they support the concept but want to hear more details.
- 3. Proposed Ordinances
  - a. Including parking prohibited on the east side of Hance Street for the entire length:

After a short discussion about the parking issues on that street, Mayor Chegwidden opened the meeting to the public.

<u>Pat Daley, St. Mary's Street:</u> Ms. Daley advised that the problem with the right side is deep sewer grates. Mr. Rheinhardt advised that those will be fixed when the road is re-done.

After more discussion everyone agreed with the proposed ordinance.

b. Road Markings- Adding the following:

"Road Markings"

When The Director of Public Works shall cause lines or appropriate markings to be painted on the surface of a municipal roadway outlined and designated each parking space. Every vehicle shall be parked within the lines or markings.

It shall be unlawful for any operator to park any vehicle outside of the lines or markings or to park any vehicle in such a position that it shall not be entirely within the space designated by the lines or markings.

The Police Chief made the recommendation for this ordinance, because it will be needed for enforcement with the updates to Main Street.

## Councilman Yeager: No Report

Mayor Chegwidden's Report: He would like to thank the voters who came out to the Primary Election. The Memorial Day Service was very nice and he thanks the school for allowing us to use their gym. The carnival was a success and each of the three organizations received \$5,000. He also wants to thank everyone who volunteered and made it a great event. He then gave an update on the status of the Main Street paving project being done by Morris County. He then provided the Council with some concept drawings to consider for the former bank building property. Mr. Rheinhardt advised the Council about each concept. There has also been an evaluation of the fields, particularly Lafayette Street. The company has said they can restore the field but it will need to be closed for the fall. Mr. Rheinhardt advised the Council about a grant opportunity for a trails grant. There is a range available from \$5,000 to \$420,000 with a 20% match. The match includes in-kind services. He then showed a map and with Mayor Chegwidden explained possible locations for a trail that attaches to the Morris Greenway. More discussion about this followed. No final decisions need to be made right now, but we do need to sign a letter of intent that we would be able to pay the match or use in-kind services for it. There's no commitment yet. Mr. Rheinhardt then showed the Council the trail mix suggested by the contractor for the roadway over Iron Mountain. After a short discussion, everyone agreed that they did not like the proposed mix and would like to see another proposal.

## Closed Session

Council President Norton introduced and made a motion to approve R-90-16, "Resolution for Closed Session," which was seconded by Councilwoman Hayes. This Resolution was approved via voice vote. Councilman Corbett made a motion to return to open session which was seconded by Councilman Yeager.
