Mayor Chegwidden Called the Meeting to Order

Mayor Chegwidden read the Open Public Meeting Statement

## Flag Salute

Mayor Chegwidden opened the meeting to the public.

John McCusker from 34 Ford Ave. stated that he attended the Wharton Board of Education meeting. He went to invite anyone from the school who would like to be a part of the 9/11 Memorial Committee. He stated that Mr. Herdman, Wharton School Superintendent may know of someone that has a piece of material from 9/11. Mr. Herdman would try and find out if the 9/11 Memorial Committee can have it.

## **Discussion**

# • Amending Littering Ordinance:

The Mayor and Council discussed potential amendments to the Littering Ordinance. Councilman Corbett asked if this newly updated Ordinance overlapped with our Property Maintenance Ordinance. Mayor Chegwidden stated that this was a separate Ordinance and did not overlap. Councilman Corbett asked if the term "enclosed container" meant an enclosed area for garbage cans. Gabrielle Evangelista, Assistant Administrator advised the council that "enclosed container" was a garbage can. Department of Public Works does not take garbage that is not in a garbage can. Councilman Binkoski stated that currently the Department of Public Works is leaving stickers for people who are not putting garbage in cans or who repeatedly leave out excess bags. Mayor Chegwidden suggested that Scott Hutchins, Public Works Director be invited to the next Council meeting to discuss.

### **Council Reports**

Councilwoman Hayes: Stated that the recycling center will now have new hours. The new hours have been posted and Town Hall has flyers for residents with the new information. The lawn bags will no longer be in Town Hall, they will be at the recycling center.

Councilwoman Veres: Stated that she attended the 9/11 Memorial Committee meeting.

Councilwoman Wickenheisser: Stated that the Wharton Alliance/Fraternal Order of Police Carnival is on June 7<sup>th</sup> until June 10<sup>th</sup>. We need volunteers to cover all the shifts.
