They will be resuming in a couple of weeks to finish. They are waiting on JCP&L to put in a new pole to raise the wires and provide power to Buildings E & F. They are planning to do both at the same time and then they will be able to open the west driveway. They will be installing new lights and guide rails along the west driveway. They have submitted revised plans on the conservation easement which he is reviewing. He is comfortable with their progress. He is hoping to close out the Storage Facility on W. Dewey Ave., soon.

Next, was the Continuation of the Equinet Properties application. Chairman Loury stated that they have received a letter from the Attorney for the applicant asking to carry their application to the February 12, 2019 meeting because they had just received a response from the Fire Chief dated 1/7/19 and Police Chief dated 1/3/19 and would like to have time to review their concerns.
