<u>Presentation</u>

John Manna made a presentation concerning the restoration of the Morris Canal Lock 2 East site with the assistance of Margaret Hickey, architect. They both discussed how the restoration of the lock, which is at 75% completion, and the lock tender's house could help with bringing tourism into town and revitalizing Main Street. The presentation included a video of the Greenway plans including Waterloo Village and Saxton Falls as sites undergoing restorations.
