## **Council Reports**

Council President Vasquez: The Memorial Day parade and services were very nice and well organized. She enjoyed it. They are working on changing the rabies vaccine clinic to a Saturday in October. <u>Councilman Yeager:</u> He attended the Memorial Day parade and ceremonies. The Police Department has concluded interviews and there are 2 new officers getting their background checks now. If approved, they will attend the academy soon.
