# Council Remarks:

<u>Council President Yeager:</u> He thanked everyone for a great year. Congratulations to Councilman Binkoski and Councilwoman Jones on their elections. He is looking forward to working with them.

<u>Councilman Binkoski:</u> He had the opportunity to go to the DPW with the Mayor before Christmas to have bagels and coffee with the guys. He thanked the DPW and Police Dept. for the great job handling the last snow event.

Councilwoman Jones: No report.

<u>Councilman Norton:</u> Congratulated everyone who was sworn in this evening. He also thanked the DPW and Fire Departments, stating there's "none better".

Councilwoman Vasquez: Congratulated Councilman Binkoski and Councilwoman Jones and extended an offer to help with anything she can. She reported on some of the Library's accomplishments last year. They were able to get the solar tables, expand the parking lot, and they received a grant allowing them to give 500 computers and 600 hotspots to our residents. This gave many families and children who didn't have a computer the opportunity to have a computer. The Library also hired a full-time Director last year which was very helpful. They are working to get the approval for the roof and windows project and that is happening this year.

Mr. Kovalcik confirmed the roof and window project was approved by the County.

She thanked everyone for their support.

<u>Councilwoman Wickenheisser:</u> Congratulated Councilman Binkoski and Councilwoman Jones. She also congratulated everyone sworn in tonight. Thanked the DPW for another fantastic job all year, every year, and thanked our Police & Fire Departments, who are the best around.

#### Mayor Chegwidden's Remarks

He let everyone know Assemblywoman Dunn could not be here and he put into record the letter she sent. Steve Shaw, Heather Darling and Doug Cabana also sent regrets they couldn't be here. Congratulated Councilman Binkoski and Councilwoman Jones.

Mayor Chegwidden outlined some of the Borough's accomplishments from 2023:

- Road projects completed:
  - o Lafayette Street (Grant from the NJDOT)
  - o New Irondale and Old Irondale
  - o Deszo Avenue
  - o Ross Street
- Development of Orchard Mine Park
- Completion of Irondale Trails Phase III (Grant of \$130,000)
- Purchase of a new Street Sweeper
- Installation of a bypass for Sterling Street Water tank
- Sent design for realignment of Dewey Avenue and Route 15 to the State
- Completed Host Community Agreement with Ascend
- Purchase of 5 new Police vehicles
- Refurbishment of crosswalks on Main Street
- Entered into a contract to purchase 262 West Dewey Avenue
- Additional \$319,000 recieved for the Morris Canal project
- Construction of Wharton Woods and Irondale Commons
- Construction of Pillar Care, a non-profit, on West Thomas Street
- C.O. for 10 North Main Street and the group home at 22 Sterling Street
- Many trips for our senior citizens

He then discussed some things on the horizon for 2024:

- Road Projects to be completed:
  - o Robert Street (\$271,000 Grant)
  - O Washington Street (\$648,000 Grant)
  - O Baker Avenue Phase I (\$150,000 Grant) & Phase II (\$234,000 Grant)
- New Dog Park
- Rehabilitation of Sterling Street Water tank
- Development of fields at Orchard Mine
- Overhaul of Columbia Street Park (\$76,000 Grant)
- Completion of the Morris County Canal Lock 2East project.
- Replacement of Library windows (PY CDBG Funds of \$80,000) and roof (CDBG Funds of \$49,000).

#### • New Sanitation Receptacles

He reported the ratable base has gone up \$70 million and we are now just under \$1 billion in ratables. He continued that Wharton continues to be fiscally sound. Our books are in the process of being closed for the year and he has been informed by our CFO that we ended the year on a positive note. He would like to thank all of the employees and volunteers for their team efforts to do what's best for Wharton. He is looking forward to working with this Council and he's looking forward to another great year.

#### Public Portion

Mayor Chegwidden opened the meeting to the public.

Mike Bezney, 1 Bartek Lane: Mr. Bezney congratulated the members who were sworn in and thanked Mayor Chegwidden and the members of the Council for stepping up to the plate and being our representatives. He inquired whether curbs and storm drains would be installed by the developer. It was explained that would be up to the Engineer. He expressed his need to know when his road would be paved so he can install a sewer line. He was advised by Mr. Quillinan and Mr. Hutchins that he should install his sewer line because we know the road is going to be paved.

Mayor Chegwidden closed the meeting to the public.
