

**AN ORDINANCE AMENDING CHAPTER 315, ARTICLE II, SECTION 9 AND ARTICLE III SECTION 18 OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF WHARTON, COUNTY OF MORRIS, STATE OF NEW JERSEY**

BE IT ORDAINED by the Governing Body of the Borough of Wharton that Chapter 315 Vehicles and Traffic, Article II Parking, Section 9 Parking Prohibited in School Zones and Article III Traffic, Section 18 One-Way Streets of the revised general ordinances of the Borough of Wharton are hereby amended as follows:

**Chapter 315. Vehicles and Traffic**

**Article III. Traffic**

**§ 315-9. Parking prohibited in school zones.**

- A. No person shall stop or stand a vehicle during the school year on days that the school is in session between the hours of 7:30 a.m. and 3:30 p.m. upon any of the following described streets or parts of streets:

<u>Name of Street</u>	<u>Side</u>	<u>Location</u>
Dennison Way	Both	Commencing at the intersection of East Central Avenue to Baker Avenue
East Central Avenue	North	Commencing at the intersection of Dension Way running west for 66 feet
East Central Avenue	North	Commencing at the intersection of Lafayette Street running east for 51 feet
East Central Avenue	North	Commencing at point 355 feet east of Lafayette Street intersection and running a distance of 328 feet
East Central Avenue	South	Commencing at the intersection of Dension Way running east for 631 feet
East Central Avenue	South	Commencing at the intersection of Lafayette Street to Denison Way
Lafayette Street	Both	Commencing at the intersection of Fern Avenue to Baker Avenue

- B. No person shall park a vehicle during the school year on days that the school is in session between the hours of 7:30 a.m. and 3:30 p.m. upon any of the following described streets or parts of streets:**

<u>Name of Street</u>	<u>Side</u>	<u>Location</u>
<u>East Central Avenue</u>	<u>North</u>	<u>Commencing at a point 215 feet east of Denison Way running east for a distance of 466 feet</u>

§ 315-18. One-way streets

A. The streets or parts of streets described in below are hereby designated as one-way streets in the direction indicated.

<u>Name of Street</u>	<u>Direction</u>	<u>Location</u>
Cambridge Road	Northerly	Pine Street north to Oxford Road
<i>Denison Way</i>	<i>Southerly</i>	<i>Between East Central Avenue and Baker Avenue, from 7:30 A.M. to 3:30 P.M. on school days only</i>
<i>East Central Avenue</i>	<i>Westerly</i>	<i>Between Denison Way and Lafayette Street, from 7:30 A.M. to 3:30 P.M. on school days only</i>
Luxemburg Avenue	Easterly	From North Main Street to West Dewey Avenue
North Main Street Extension	Northerly	From North Main Street to the westbound lane of State Highway Route 15
Washington Street	Southbound	From point 100 feet south of the center line of North Main Street (CR 634) to its intersection with Kossuth Street
