

RESOLUTION: NOTICE OF PUBLIC AUCTION

- 6. This resolution shall be published in the Star Ledger for two consecutive weeks with the final publication at least seven (7) days prior to the date of the auction.**
- 7. A bank check, money order or cash for the total bid is payable at the time of the auction.**
- 8. All items will be sold in an "as is" condition and all sales are final.**
- 9. For the vehicles listed by the Wharton Police Department all Towing and Storage Fees must be paid in full prior to purchase of items listed on the attached schedule.**
