

RESOLUTION RENEWING LIQUOR LICENSES

WHEREAS, the Mayor and Council of the Borough of Wharton, in the County of Morris, State of New Jersey, pursuant to the authority vested in it by an act of legislature, has heretofore by ordinance provided for the sale of alcoholic beverages in the Borough of Wharton; and

WHEREAS, the following named Liquor License holders have filed an application for license renewal and the Borough Clerk has received a Tax Clearance Certificate for these establishments;

NOW, THEREFORE, BE IT RESOLVED that the following liquor licenses, known as Plenary Retail Consumption Licenses be granted renewal for the period of July 1, 2026 to June 30, 2027:

*License is granted with the following conditions:

1. All outside operations will end at 10 p.m.
2. All patrons will be moved indoors at 10 p.m.
3. There will be no games, competitions or the like permitted outside.
4. There will be an employee present outside at all times when patrons are present.
5. There is to be no entertainment or amplified music permitted outside.

**License is granted with the following conditions:

1. During the hours when entertainment is provided, bands, disc jockeys and the like, Luna Restaurant & Bar, LLC is required to provide adequate security for crowd control. Two security persons for the first fifty (50) patrons and an additional security person for every additional fifty (50) patrons until the maximum occupancy of the establishment has been reached.

2. Cameras shall be installed to monitor all public areas. The equipment shall record continuously during business. Business hours shall include all times when patrons or employees are inside the establishment. The video footage shall be maintained for a period of thirty-days and made available to police for review and/or copy upon request.
3. A security guard must be stationed outside during closing.
4. Operational hours shall be as permitted by municipal ordinance for all plenary retail consumption licensees in the Borough of Wharton. Luna Restaurant & Bar, LLC shall have last call at 1:00 am, last service at 1:30 am and "lights on" at 1:30 am. Prior to 2:00 am, Luna Restaurant & Bar, LLC will take all efforts to require patrons who are waiting for transportation to remain inside the establishment, rather than outside.
5. On Friday through Sunday, from 11:00 pm until close, security personnel shall be stationed at the Fern Avenue exit to prohibit patrons from exiting with any open containers or any alcoholic beverages.
6. Signage shall be posted at all exits reading "No open containers or alcoholic beverages permitted beyond this point."

BE IT FURTHER RESOLVED that the following liquor licenses, known as Plenary Retail Distribution Licenses be granted renewal for the period of July 1, 2026 to June 30, 2027:
